Minutes - Deene & Deenethorpe Parish Council Meeting Tuesday 6th January 2015 in Deene village hall at 7.30pm

- **357. Present:** Stuart Barratt, Annette Blackmore, Robert Dolby, Brian Gretton (Chairman), and Graham Holding and plus the clerk. Apologies received and accepted from Mark Martin who was unwell.
- **358.** There were no declarations of interest on items for discussion on this agenda.
- **359.** It was **RESOLVED** to approve the minutes of the meetings of November 2014 as a true record of proceedings.
- **360.** There were no public questions or presentations to the council.
- **361.** No neighbourhood watch or community safety matters had been received. There was a discussion regarding recent suspicious activity in the village and speculation about burglaries in other communities. The parish council is concerned that people maintain vigilance especially during the darker evenings.
- **362.** PLANNING MATTERS:
- **363.** 14/02272/LBC | Alterations of existing outbuilding to form additional toilets and alterations to existing internal WC, new internal doorway, door and lintel over. | Deene Hall Deene Park Deene It was **RESOLVED** to submit no objections or further comment to this application.
- **364.** Neighbourhood planning update: No further information regarding 'lighter touch' neighbourhood planning had become apparent since the last meeting. The council is very keen to implement a neighbourhood plan, but has very limited resources with which to do so.
- **365.** The chairman advised that he would be attending the development control committee meeting to put the parish councils view of the proposed extension at 9 Deenethorpe.
- **366.** GOVERNANCE MATTERS: There were no points to discuss
- **367.** HIGHWAYS MATTERS: The clerk undertook to forward the necessary weblinks for contacting "Streetdoctor", the online reporting system for Northamptonshire County Council highways issues.

368. COMMUNITY MATTERS:

- Flooding issues A meeting has been convened for 16th January between the parish council, the Environment Agency, the flooding consultants employed by Northamptonshire County Council and Deene Park. There was a wide ranging discussion regarding the fact that the 'new' houses at the bottom of Avery Hill, opposite the brook have been designated flood zone by the Environment Agency. The various causes of the run off flood water and the lack of drainage caused by the over silted lake were discussed at length. It is hoped that the meeting will prove positive and that constructive actions will result from it.
- Village Hall there was a discussion regarding the village hall committee which is due for re nomination at the upcoming annual general meeting. There are relatively few committee members and regular fund raising activities, which means increased voluntary activities for those members and inconsistent support from the village because of people's commitments. The parish council concluded that it wants to support the village hall committee in its endeavours and will make a financial contribution in the coming financial year.
