1. **To note attendance and receive apologies for absence.**
2. **To receive *declarations of interest* on items for discussion on this agenda.** Or application for a *dispensation*
3. **Opportunity for input from Police** – The intention is that a representative from the police will attend each parish council meeting to report on anything of note and discuss collaborative approaches to the *Futures* programme
4. **Opportunity for public questions or presentations to the council** No decisions can be made regarding matters about which the parish council has not previously been fully apprised.

8. **Joint planning Unit Core Strategy** – Confirm which members will be attending the forthcoming Hearing Sessions of the Inspector's Examination of the North Northamptonshire Joint Core Strategy Matter 10, Deenthorpe Airfield, which is due to take place on the morning of 26th November at East Northants Council Offices in Thrapston.
9. **Deenethorpe Airfield** – Decide which members will sit on the working party organised by East Northamptonshire Council. Consider option to have 2 nominations plus a reserve.

11. **Highways issues:**
 - a) Consider further investigation into taking over verge grasscutting function from KierWSP for 2016 onwards so that public verges and areas are cut more frequently. Specification, detailing the number of times cuts will be carried out detailed *HERE, map* of Deenethorpe. Next step would be to invite tenders based on an increased number of cuts, to be decided.
